

Certification of Financial Responsibility (CFR)

In order to receive the Form I-20 necessary to apply for an F-1 Student Visa to attend our institution, you must submit financial certification that you will have sufficient funds of at least \$12,000 U.S. Dollars to support yourself during the academic year.

Each sponsor must complete a Letter of Support. If you are paying your own tuition and expenses, you are considered the sponsor. If you are receiving a Government Sponsorship or Scholarship, you must submit a signed copy of the award letter with the details of the award or scholarship.

Incomplete or incorrect CFR will delay or prevent the issuance of a visa certificate. Be sure to make copies of all documentation for your own records.
