# MNWEST COMMUNITY & TECHNICAL COLLEGE MEDICAL LABORATORY TECHNICIAN ADVISORY BOARD MEETING October 26, 2017

The MWCTC Medical Laboratory Technician Advisory Board meeting was held October 26, 2017 at the Luverne Center, 3:00 p.m. in Room 142

Members present: Rita Miller (MLT Program Director), Rejean Knobloch (Sanford Rock Rapids and Sanford Luverne Hospital), Julie Stevens (Pipestone County Medical Center), Jane Polz (Windom Area Hospital), Kris Schneekloth (Sanford Regional Hospital Worthington), Deb Dummer (Redwood Area Hospital), Jackie Otkin (Dean of Allied Health), Lexy Krull (Adjunct faculty), and Vonnie Hinrichsen(Sanford Sheldon Medical Center).

## **GENERAL INFORMATION:**

Jill Arp and Jackie Otkin gave an update on the Luverne Center and marketing. Jill started in September as Resource Specialist. She will be working closely with students. Recruiters are going to going to try to get instructors into the classrooms. She also mentioned that the Administration structure has changed. They are going away from Deans on each campus. A dorm is going to be built at the Worthington campus. Information can be found on the website. The pharmacy Tech program will become part of Customized training. It will consist of 200 hours.

Introduction to HealthCare Careers course for High School students began this semester. In Luverne there are 21 students, Windom has 18, and it was unknown how many in Granite Falls.

## **OLD BUSINESS:**

**TOPIC:** Feedback from weekly evaluation implemented last year DISCUSSION: Overall, everyone liked the weekly evaluations during Clinicals. It gave the student and Program Director an up-to-date assessment of the student. CLOSED

**TOPIC:** Reduction of microbiology hours

**DISCUSSION:** Due to the fact that more hospital labs are outsourcing their microbiology it is becoming more difficult to find labs for microbiology Clinical rotation. Rita mentioned that MN West is looking at simulation of microbiology lab on campus. The MLT program was awarded \$30,000 through Perkins' Grant for an Autoscan Micro 4 Microscan. Additionally, Kristin Fritz who is adjunct faculty has begun a master's program at UND. For her special project she is considering writing a plan for the Simulated Microbiology Lab. UND has a new microbiology simulated lab.

## **TOPIC:** Capstone course-Feedback

DISCUSSION: June 2017 was the first time the Capstone class was offered. The objective was to increase the number of students pass rate and increase the scores. The Capstone course consists of discussion of professionalism, writing a resume, interviewing, and reviewing for the Board Exam. So far 7 out of 8 students have passed their exam. Scores were higher. 559, 541, 676, 430, 557, 417 and 620. See handout for more data

## **TOPIC: Background Studies**

DISCUSSION: Minnesota Department of Health has implemented fingerprinting. For Federal background studies, which includes criminal records, Minnesota West has changed to Castlebranch. All students are required to use them.

## **TOPIC:** Immunization and test for tuberculosis

DISCUSSION: Some changes for immunization requirements have been noticed; especially for tuberculosis. Redwood Falls and PCMC using the 2 step, Windom, Worthington, Rock Rapids, Luverne, and Sheldon use Quantiferon. Additionally, if student has had chicken pox a titer must be done to prove immunization. All hospitals are requiring an influenza vaccination. CLOSE

## **TOPIC:** Enrollment

DISCUSSION: 8 first year students started in August. There are 6 females and 2 male. One student is going very part-time and one is attempting classes for the second time. One student have a B.S. in Biology. Clinical sites have been established for the eight second-year students. VA Hospital in SF is taking 2 students; which is the first time they have taken students.

DISCUSSION: Rita stressed the importance of making sure the students have their competency checklists with them all the time. Suggestion was made to stress that phlebotomy is required and that students need to "step up an help out" when possible. Rita will emphasize this to the students going to Clinicals in January.
