THE FOLLOWING APPLICATION EXPLAINS HOW TO RESERVE A ROOM AT CARR RESIDENCE HALL

- COMPLETE APPLICATION** - Complete the application below. Return it with the security deposit (payable to Minnesota West, Canby Campus by check or money order) to: Carr Residence Hall, Minnesota West, 1011 First Street West, Canby, MN 56220. The security deposit will be returned to you when you vacate the residence hall in the spring provided there are no facility damages.
- WE WILL RESERVE A ROOM FOR YOU** - Upon receipt of the Application and the security deposit, we will reserve a room for you and mail you a contract which must be returned within **15 days of receipt**. If space is no longer available, we will automatically place you on our waiting list. Rooms are open until filled. Room assignments are based on the order in which housing contracts are received. Rates are subject to change. PSEO students are not eligible to reside at Carr Hall.
- RETURNING STUDENTS- Returning Students** will have up to **November 1** to submit their application and security deposit if they want to reside at Carr Residence Hall the following year. After November 1, all applications including new and returning students will be reviewed and accepted by the date their application was fully completed.
