

INVESTMENTS

ACROSS THE COLLEGE

Each campus of Minnesota West benefited from focused investments in infrastructure and program enhancements this year. Here some highlights of strategic investments across the college.

CANBY CAMPUS

The Canby Campus Electrician and Wind Labs underwent a significant expansion over the summer of 2019. The updated Wind & Electrical Lab is 4,700 square feet and allows for lab work in multiple courses to be run simultaneously.



GRANITE FALLS CAMPUS

The Powerline Technology program expanded to the Granite Falls campus in 2019, with new students beginning their Powerline training over summer.



A new digital sign replaced the current college sign along the highway that had been in place for over 30 years.




JACKSON CAMPUS

LUVERNE CAMPUS

New Radiographic Imaging Systems were installed at the Luverne Center to ensure up-to-date training for Radiologic Technician students.

The Dental Assistant program was expanded to the Luverne Center in 2019.



PIPESTONE CAMPUS

An updated nursing simulation lab was built on the Pipestone Campus.

The Plumbing and Heating Technology (originally HVAC) program has also been re-vitalized on the Pipestone Campus.



WORTHINGTON CAMPUS

The Worthington Campus updated the look and feel of its campus for the public, including updates to the student commons, furnishings in the LARC (Library and Academic Resource Center), and its main entry.



Donations & Partnerships

Minnesota West Foundation Receives \$15,000 AT&T Foundation Grant



The Minnesota West Foundation received a \$15,000 grant from the AT&T Foundation to support its scholarship programs during an event on campus October 16, 2019.

The AT&T Foundation grant will support scholarships for tuition, fees and supplies so that under-served students without a high school diploma can take college level classes that will prepare them for careers in high demand occupations. Students in these courses will gain the skills and training they need for high-demand jobs in the tri-state area of southwestern Minnesota, northwestern Iowa and southeastern South Dakota.

"With this grant from the AT&T Foundation, we are excited to provide scholarships to students enrolled in courses in high-

demand occupations, including welding, information technology and community health among others," said Terry Gaalswyk, Ph.D., President of Minnesota West Community and Technical College. "We know these are high-demand fields for our tri-state area, and we need to make sure we have a workforce trained for these jobs. We are grateful to the AT&T Foundation for helping our students with financial need gain the education they need for the workforce."

"For more than a century, education has been a top priority for AT&T," said Paul Weirtz, president of AT&T Minnesota. "On behalf of the AT&T Foundation, we are proud to support the scholarship programs at Minnesota West and help local students receive the education they need to be prepared for careers in the 21st Century."

Wind Turbine Nacelle Donation

The Wind Energy program in Canby, MN received the donation of a wind turbine nacelle from NextEra Energy Resources LLC this past summer.

Weighing approximately 180,000 pounds, the nacelle houses all the generating components of a wind turbine. The nacelle will be incorporated into the program's curriculum and will provide students with hands-on training. NextEra Energy Resources' subsidiaries currently own and operate two wind facilities in Minnesota. This particular nacelle was transported from its Lake Benton II Wind Energy Center in Pipestone County, MN.

"The nacelle provided by NextEra is coming directly from a working wind farm," stated Bruce Peterson, Minnesota West Dean of Energy Technologies and interim Provost. "We greatly appreciate the benefits our students will have to enhance their educational experience."



"We are proud to partner with Minnesota West Community and Technical College's Wind Energy Technology program and contribute to such a prestigious training program for wind turbine technicians," said Danell Herzig, NextEra Energy Resources project director. "Wind technician is one of the fastest growing jobs in the United States, so the direct experience these students can receive from working with the equipment will help them as they progress in their journey to becoming a wind technician."
